

With respect to each parcel of real property or item of personal property identified in question 1, describe the nature and location of the dangerous condition, whether environmental or otherwise, that poses or is alleged to pose a threat of imminent and identifiable harm to the public health or safety (attach additional sheets if necessary):

This property was leased from a former landlord by the name of Brauvin. In 2001, Metromedia Steakhouses Company assigned their interest back to Brauvin in a Lease Assignment, Assumption and Release agreement, but they indemnified Brauvin for the environmental issue. The issue is that the property used to be a gas station and there was a leak. Brauvin sold the property to Elm Partners who then sold it to the current owner, FL Brandon LLC c/o The Fraternal Clubhouse, LLC; however, the indemnity survived the transfers of ownership and Metromedia Steakhouses Company is still responsible for the continued clean up and monitoring.
